### The Rector's Report 2013

The year 2013 has been another fantastic year for our Benefice!

In 2013 our Benefice has once again been the setting for a number of very special events and services. In Holy Week St Leonard's Church hosted the Chrism Mass at which two Archbishops were present! Father John Sentamu the Lord Archbishop of York and Father David Hope the former Archbishop of York. In June St Leonard's hosted a special Parade Service to celebrate the 60<sup>th</sup> Anniversary of the Coronation of HM The Queen. In August St Helen's celebrated St Helen's Day with Patronal Evensong & Benediction, where our guest preacher was the former Bishop of Whitby, Bishop Gordon Bates. In November St Leonard's Day was kept with a Prayer Book High Mass, our guest preacher being Father Clay Roundtree, Vicar of Ingelby Barwick.

Ecumenical relations have remained positive. We have continued to work with the local Methodist community and with their minister the Rev Grace Seymour. Good relations have also continued to exist with the Roman Catholic Community, especially with the priest and people of SS Joseph and Cuthbert's Loftus.

The Benefice has also continued to enjoy good relations with the wider community and as a Benefice we now routinely work in partnership with the Town Council and with other Community Groups and Organisations.

### Independent examiner's report to the trustees of St Leonard's Parish Church Loftus in Cleveland

I report on the accounts of the church for the year ended 31 December 2013, which are set out above.

#### Respective responsibilities of the PCC and their Examiner:

The PCC is responsible for the preparation of the accounts. The PCC considers that an audit is not required for this year (under Section 144(2) Charities Act 2011 (the 2011 Act)) and that an independent examination is needed.

It is my responsibility to:

- examine the accounts under Section 145 of the 2011 Act;
- to follow the procedures laid down in the General Directions given by the Charity Commission (under Section 145(5)(b) of the 2011 Act); and
- to state whether particular matters have come to my attention.

#### Basis of the independent examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair view ' and the report is limited to those matters set out in the statement below.

### Independent examiner's statement

In connection with my examination, no matter has come to my attention:

During this year The Rural Dean, Graham Pacey has retired and Rev Rachael Harrison has been appointed in his place.

Jo Bowden from Wellspring has been appointed as an officer for children and youth work in the diocese.

In the absence of an incumbent Wilton Parish will be led by the lay reader as 'Focal Minister of the people.'

A new plurality has been formed of New Marske with Saltburn with another minister being housed at New Marske.

### Financial Report 2013

Firstly, I give my grateful thanks to Mrs. Joyce Partlett, who so ably carried out my duties whilst I was on my extended holiday.

All Assigned Fees and invoices have been paid and the Parish Share for the year paid in full.

Expenses continue to exceed income and over the year it was necessary to withdraw £6,628.50 from the PCC Savings Account to pay for the church insurance, some church maintenance, parish share and to maintain a prudent balance in the PCC Current Account.

£878.58 was drawn from the Designated Fabric Account to pay invoices.

We must carefully monitor all expense and strive to increase income.

As most people know over the years we have had a successful stewardship scheme which means that we can claim back the tax from the government that you have already paid. I would like to thank all those who take the time and trouble to support the church in this way. Can I ask that you send back your signed declarations that are in the new boxes of envelopes so that we can keep our records up to date.

During the last year the Revenue introduced an additional section to our claim. As well as claiming the tax back on the gifted amounts we are now able to claim the tax amount back on non-gifted aided money that is put on the plate e.g. at weddings, baptisms and funerals. In this last year this has meant that we have received an additional £1,000.

# Churchwardens' Fabric Report 2013

The Churchwardens give thanks and a few words of praise to everyone involved in the support of, and the running of the church over the past twelve months. The church looks beautiful, the flowers always superb, the church services well received and enjoyed. Fundraising activities were once again very successful and reflected the effort put into them. Special thanks to Fr Adam for his dedication, and organising skills which greatly eases the tasks we do.

The Archdeacon made his visitation early in the year and complimented us on the good state and look of the building.

### Over the year:-

The black gates in the choir screen have been painted.

The interior of the church has been painted.

The floor tiles have had a few more coats of polish but need more.

The gutters and down pipes have been cleaned and the top of the tower has been inspected and flashing and tiles have been replaced. The small 'tree' has been removed from the North Nave gutter.

The radiators and the floor grids near the altar have been painted so that they match the gates.

Chubb have been to service the fire extinguishers.

Clock. We have been in touch, once again, with the Cumbria Clock Company and they informed us that the new regulatory device has gone into production and that we should hear from them within two weeks. They also said that the 10 year guarantee will start once the clock is running correctly.

Eagle. This has landed and looks marvellous.

The red frontal has been taken away for refurbishment and should be back with us before too long.

The soak away drains need cleaning out in the future.

The Quinquennial was carried out and hi-lighted works that we will have to tackle in the near future or within the next 5 years – pinnacles, stained glass window, stonework, lightning conductor, bells e.g. some of these are already in hand but will not be completed until 2014.
